Mr. Marquez commented on the on-going road conditions around Chino. Specifically the stop sign at Sultana is hidden by a road sign.

Mr. Bagley welcomed Mr. Godown back. Mr. Jenkins added that the hand-over of the department leadership was unique in the County as the director's position will be dual-filled through the end of March 2024.

Mr. Marquez requested that the County CEO be invited to the Chino meeting. The State of the County is approaching, and the Airport Commissioners should be included.

10. Information Item: Chino Airport Traffic Circulation / Right of Way Dedications

Mr. Jenkins reported on the following items:

- Kimball Avenue widening and Edison pole relocation.
- Stormwater conveyance structure.
- Merrill Avenue widening. Once Right of Way/Right of Entry for construction is in place the construction on the south side of Merrill will begin for approximately 4 6 months.

Mr. Marquez shared that improvements on Euclid Avenue/Highway 83 (Euclid) are being managed by the Cities of Ontario and Chino. Both cities are looking to control access points from Euclid and are working with Caltrans for long-term control and encroachments into developments.

Ms. Snelgrove presented an overview of the terminal remodel, café patio expansion and parking lot rehabilitation.
